PROGRAM

The CSA Bangalore Summit commenced with Ekta MISHRA (APAC Membership Director & Country Manager India, CSA) and Jim REAVIS (CEO & Co-Founder, CSA) celebrating the 10th year anniversary of CSA and what the future holds in its second decade. This was followed by a stellar line-up of 12 presentations and a panel discussion, delivered by renowned individuals in the tech industry. Key topics covered included “How to Build Awareness Training into Your Cyber Resilience Strategy”, “Connected Vehicles Security Ecosystem & Challenges”, “Baggage Check-In to the Cloud”, “IoT Cyber Warfare”, “Threats against Modern Cloud Service Infrastructure: Detection and Mitigation”, “Top Cloud Data Breaches and Lessons Learned”, “Building a Foundation for Successful Cyber Threat Intelligence Exchange”, and panel discussion on “Regulations are hindering cloud adoption - True or False?”.

Other presentations were made by the industry’s thought leaders and eminent individuals in cloud computing, who spoke on topics such as:

- Ravikishor MUNDADA, CEO, Center of Excellence in Cyber Security, Government of Karnataka) spoke on "Cybersecurity Public/Private Partnership Work - Addressing Challenges" at CSA Bangalore Summit on 9 September 2019. His main points were: (a) Addressing the Cybersecurity PPP challenges from the perspective of stakeholders which includes - CISO, MD, Startups, Policy Makers, Industry Bodies such as CSA, FICCI, Individuals & Cybercriminals. (b) Cybersecurity is possibly the only segment that is negatively biased and we have huge challenges of building 'positive industry' around it.
- Dr. Lopa Mudraa BASU (Global Head Cyber Security Risk, Governance & Compliance, Nissan Motors) presented on "Connected Vehicles Security Ecosystem & Challenges".. Her talk covered the following main points & aspects (a) Components of Modern Car (b) Connected car landscape (c) Connected ecosystem (d) Key Vulnerabilities (f) reference from CSA Observations and Recommendations on Connected Vehicle Security.
- Anoop DAS (Enterprise Manager, Middle East and India, Mimecast) presented on “How to Build Awareness Training into Your Cyber Resilience Strategy” and laid emphasis to a point that 90+% breaches involved human error! It’s critical for enterprises to strengthen the firewall integrating with proactive & comprehensive security.
- Prakash PADARIYA (CISO, GE India Technology Center) presented on "IoT Cyber Warfare". His talk focused on (a) IoT is going to grow, reaching 50 billion+ in the next few months. (b) Every industry is in IoT race to design its products more smarter for better customer adaptability (c) Drone Hacking – Game Changer in IoT & Aviation world. He also laid emphasis on no standards around AI (Artificial Intelligence) & ML (Machine Learning). An area for CSA to bring clear & better regulatory guidelines before something really turns into “Skynet” (Ref: Fictional artificial neural network of Terminator series).
- In his presentation on “Building a Foundation for Successful Cyber Threat Intelligence Exchange”, Haojie ZHUANG (Research Director APAC, CSA) provided insights on key

considerations for corporations seeking to collaborate on security incidents impacting the cloud environment.

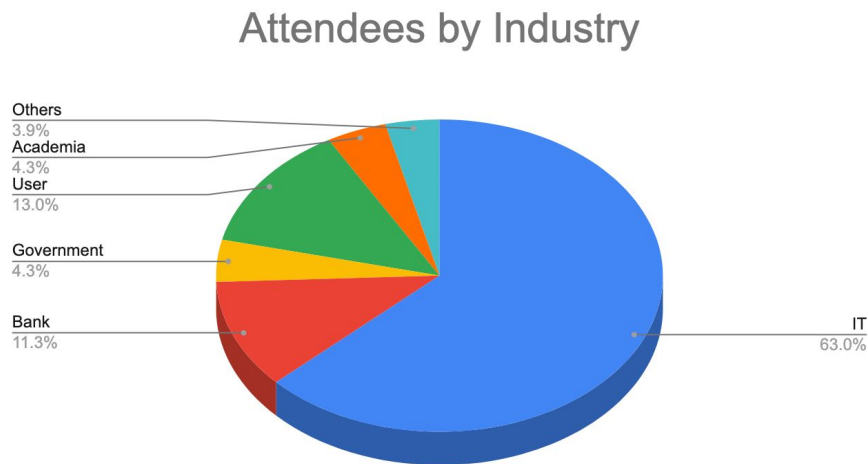
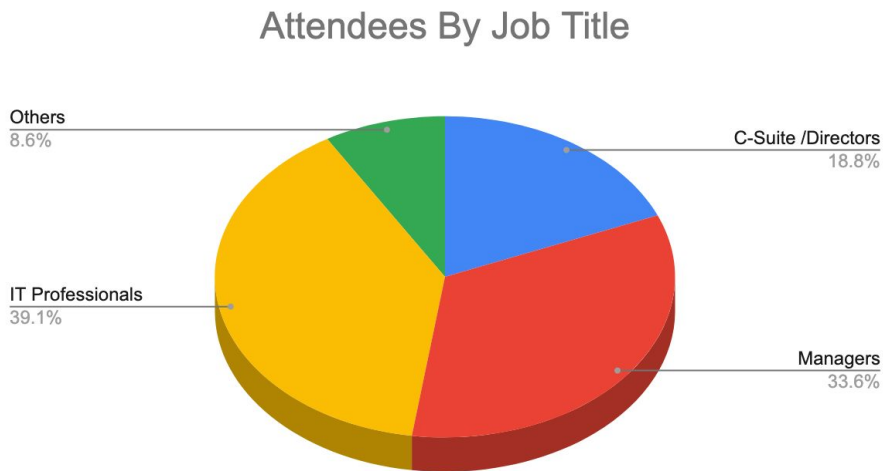
