But as cloud ventures into and interacts with different facets of technology, it is key to take a step back and learn about cloud beyond its surface, from its security specifications to dealing with incidents such as data breaches, in order to better strategize your business for the ever-evolving technology. Join leading experts with domain proficiency to discuss salient topics and trends in the cloud.

PROGRAM

The CSA Hyderabad Summit commenced with Jim REAVIS (CEO & Co-Founder, CSA) and Ekta MISHRA (APAC Membership Director & Country Manager India, CSA) celebrating the 10th year anniversary of CSA and what the future holds in its second decade. This was followed by a line-up of 10 presentations and panel discussions, delivered by renowned individuals in the tech industry. Key topics covered included "Cloud Migration strategy, CSP Governance framework", "Observation and Recommendations on Connected Vehicle Cyber Security", "DevSecOps for Cloud & Best Practises", "Opportunities of Cross-Asia Collaboration on Secure Containers & Microservices", "Blockchain Distributed Ledger Technology Use Cases", "CCSK – Your Route to a Secured Cloud Foundation", and two panel discussions on "Keeping Up with the Complexity - Security in Tomorrow's Cloud Environment" & "Privacy Laws, Global Business and Cloud - How to Strike a Balance!".

Other industry's thought leaders and eminent individuals in cloud computing spoke on topics such as:

- Cloud can help unleash innovation (especially open innovation) and strengthen security. Keynoter Dr. Sriram BIRUDAVOLU (CEO, Cyber Security Centre of Excellence, DSCI) stated the importance of how Cloud Computing is becoming prevalent in the industry with an explosive growth on the IoT side, Fog and Mist Computing. Organisations like CSA play a very key role in fostering best practices in Secure Cloud Computing, and hence are very important to the industry ecosystem.
- The use of IT requires governance, which should not be seen as barriers to agility. Ritesh MISHRA (Global Head IT Infrastructure & Security, Dr. Reddys Laboratories) presented on "Cloud Migration strategy, CSP Governance framework". He covered CISO or CIO's concerns on how to maintain compliance and governance of the data and cloud adoption strategy which enterprise users should follow. One of the recommendations was to consider deploying Cloud Access Security Brokers (CASBs) if cloud is part of the enterprise IT strategy. CASBs can help address 9 of the 12 top threats ([CSA's The Treacherous 12 – Top Threats to Cloud Computing](#)). Enterprise looking to redefine their security for cloud and build cloud governance framework should consider the use of CASBs.
- Mohit RAMPAL (Member, CSA Delhi Chapter) presented on "DevSecOps for Cloud - How to use Best Practices of DevSecOps for a Secured Development Environment". His presentation focused on CSA's recently released research report on "[Six Pillars of DevSecOps](#)". He explained how DevSecOps has positively impacted efficiencies for businesses today, especially in the cloud environment. He dwelt on the importance of DevSecOps in terms of shortening time required to go-to-market without compromising security. Mohit also shared DevSecOps best practices, such as selecting the right tools to ensure collaboration and integration, and emphasis on security to cover the entire spectrum.

- The panellists at a panel discussion on "Privacy Laws, Global Business and Cloud - How to Strike a Balance!", unanimously agreed that although enterprises are faced with the difficulties of interpreting complex privacy regulations, there is, and will continue to be a strong movement towards cloud adoption in order to scale up services with agility. In order to help understand and tackle privacy challenges, legal departments should work hand-in-hand with technical teams to simplify steps for compliance. The market will reward providers who are able to offer solutions that accommodate data privacy regulations across jurisdictions.




STATISTICS
