Leading experts from Cambodia with domain proficiency and expertise discussed key issues and trends facing cloud security and cybersecurity today at this inaugural virtual Summit organized by CSA APAC and Protem Committee, CSA Cambodia Chapter on 25 November 2020.

PROGRAM

The CSA Cambodia Virtual Summit commenced with welcome remarks from Ou PHANNARITH (Director of ICT Security, Ministry of Post and Telecommunications (MPTC), Cambodia) and opening keynote address by Dr. Sang SINAWONG (Under Secretary of State, MPTC, Cambodia).

The program saw a stellar line-up of presentations and panel discussion key topics that included:

- “Towards a Secure Cloud Ecosystem in Cambodia”
- “ICT Development in Cambodia”
- “Cloud Security 101”
- “Securing the Cloud via CCSK”

and a panel discussion on

- “Journey to Cloud Adoption”

Other industry thought leaders and eminent individuals in cloud computing and cloud security spoke on topics such as:

- In the welcome remarks by Ou PHANNARITH (Director of ICT Security, Ministry of Post and Telecommunications (MPTC), Cambodia) & opening keynote by Dr. Sang SINAWONG (Under Secretary of State, MPTC, Cambodia) shared Cambodia cyber threats and why they are doing to mitigate them.
- Dr. Hing-Yan LEE (EVP APAC, CSA) in his presentation on “Towards a Secure Cloud Ecosystem in Cambodia” shared about a model of cloud ecosystem and the building blocks that are required to build a trusted environment that is crucial for successful cloud adoption in a country.
- Mok KHEMERA (Director of E-Government) gave an informative update on the state of “ICT Development in Cambodia”. He spoke about the journey of ICT development and the various plans of MPTC e-government towards this for 2018-2023.
- Sarbojit M BOSE (Education Director, CSA Singapore Chapter & CCSK Instructor) gave a brief overview of basic cloud computing concepts, security considerations in the cloud environment, governance & risk context in cloud computing, global cloud regulations in his presentation on “Cloud Security 101”.
- As organizations migrate to the cloud, they need information security professionals who are cloud-savvy. Ekta MISHRA (APAC Membership Director & Country Manager - India, CSA) shared how CCSK which is widely recognized as the standard of expertise and provides individuals with the foundation they need

to secure data in the cloud and provide an important first step in establishing baseline knowledge for individuals in cloud security.

- The panel discussion on “Journey to Cloud Adoption” was moderated by Ou PHANNARITH (Director of ICT Security, MPTC, Cambodia) and panelists included Mok KHEMERA (Director of E-Government), Dr. Hing-Yan LEE (EVP APAC, CSA) and Nipaul LONG (CTO, PlasGate Co., Ltd.). They discussed the organizations’ role in cloud adoption, cloud adoption readiness in the region and the challenges the industry encounters in moving to the cloud.

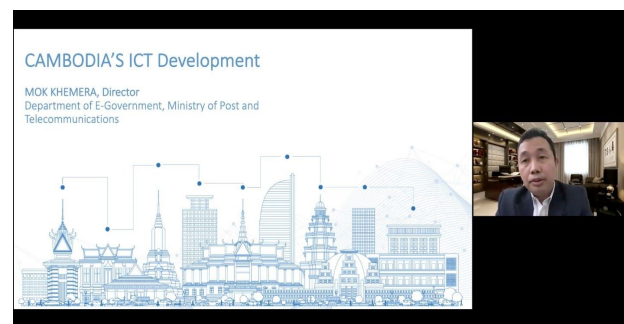

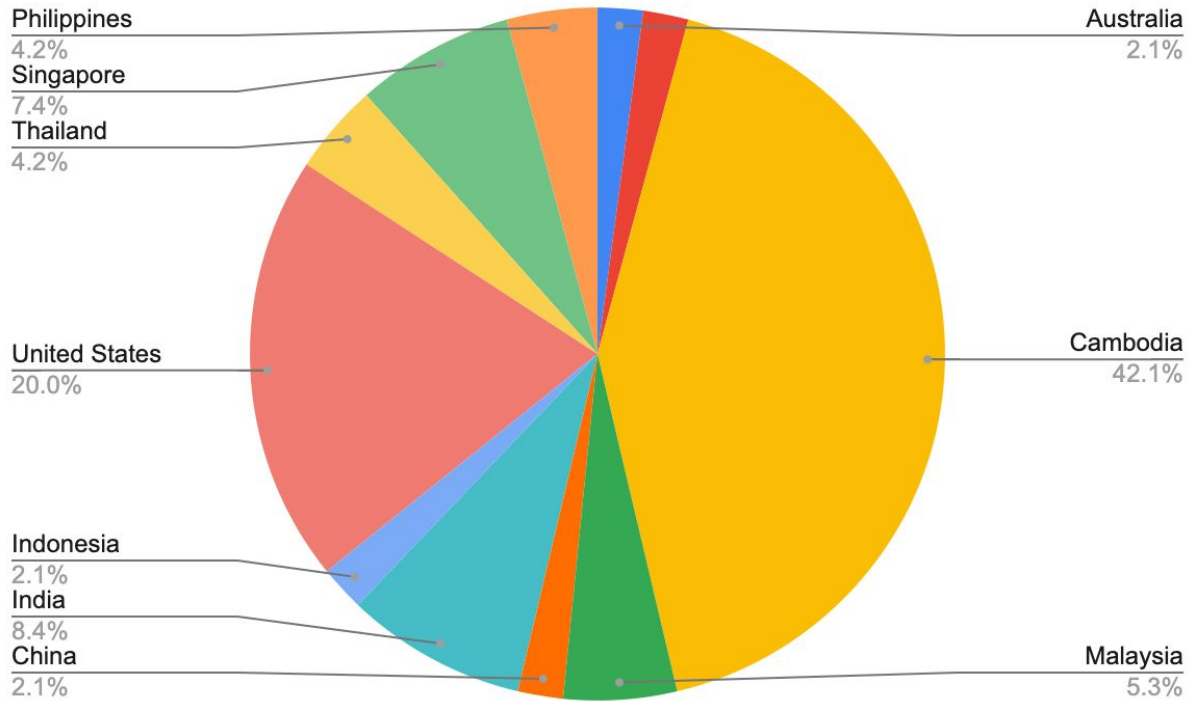




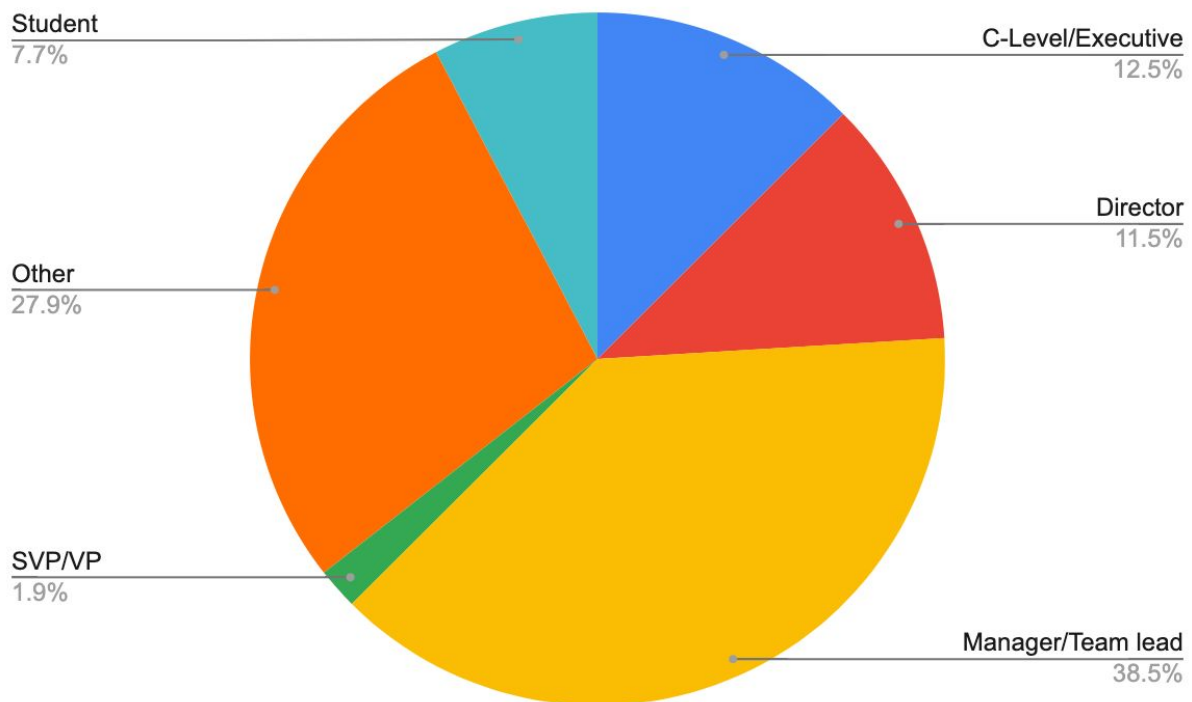
STATISTICS

By Country

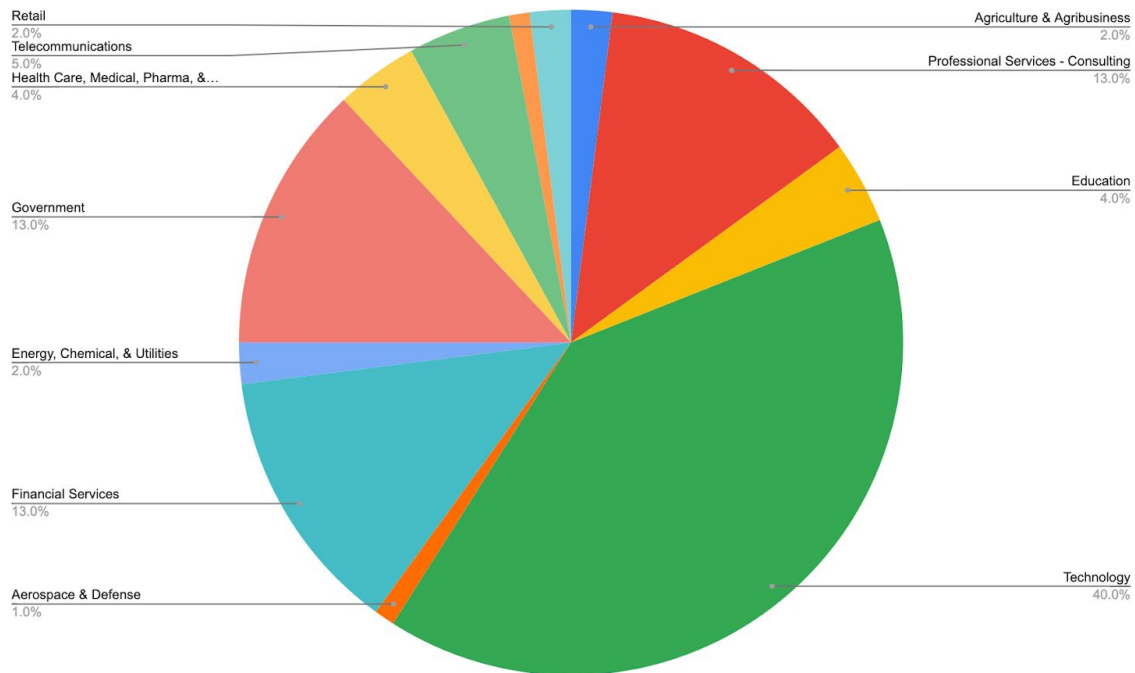


By Job Profile
