Leading experts from Malaysia with domain proficiency and expertise discussed key issues and trends facing cloud security and cybersecurity today at this virtual Summit organized by CSA APAC and Protem Committee, CSA Malaysia Chapter on 16 December 2020.

PROGRAM

The CSA Malaysia Virtual Summit commenced with Introduction from Sureen SUBRAMANIAN (Chairman, Protem Committee, CSA Malaysia Chapter), Welcome Remarks from Dr. Hing-Yan LEE (EVP APAC, CSA) and an Opening Keynote address by Dato' Dr. Haji Amirudin bin Abdul WAHAB (CEO, Cyber Security Malaysia).

The program had a stellar line-up of presentations and panel discussion key topics that included:

- “Cloud Adoption - Cybersecurity Opportunity, Threats and Practices”
- “Navigating Through the Pandemic: A MAVCOM's Cloud Journey”
- “Protecting the Cloud - New Approach”

and a panel discussion on

- “The Rush to Cloud Adoption - Watch Your Steps”

Thought leaders and eminent individuals in cloud computing and cloud security who spoke included the following:

- In the opening keynote address by Dato' Dr. Haji Amirudin bin Abdul WAHAB (CEO, Cyber Security Malaysia) on “Cloud Security Landscape: Challenges & Possible Solutions,” he covered the current digital landscape in Malaysia and cloud security precautionary measures on how to overcome the security and privacy challenges.
- Ser Yoong GOH (President, ISACA Malaysia Chapter) gave an informative presentation on “Cloud Adoption - Cybersecurity Opportunity, Threats and Practices”. He shared awareness of cloud security and covered the common cloud risks and potential challenges faced with cloud adoption. These include appropriate security controls be it from management or assurance perspectives that organizations should consider when moving to the cloud.
- Ts. Saiful Bakhtiar OSMAN (Head of ICT, Malaysian Aviation Commission) shared MAVCOM’s experience on how this economic regulator for the aviation industry has set the trend as an early cloud adopter and how cloud has benefited the industry in navigating through this pandemic time with ease.
- Soumo MUKHERJEE (Head of Strategy & Architecture - Cyber Security, Petronas) in his presentation “Protecting the Cloud - New Approach” shared that most organizations have adopted cloud computing to varying degrees within their business and adoption is rapidly increasing. The adoption of cloud comes with the need to ensure that the organization’s cloud security strategy is capable of

protecting against the top threats. He shared advantages of moving to the cloud managing threats and concerns related to cloud security.

- The global pandemic and the associated lockdown in many countries have been an inflexion point in the adoption of cloud computing; we have observed increased usage and adoption. The panel discussion on “The Rush to Cloud Adoption - Watch Your Steps” was moderated by Dr. Hing-Yan LEE (EVP, APAC, CSA) and the panelists included FONG Choong Fook (Director, LGMS), Ser Yoong GOH (President, ISACA Malaysia Chapter), Victor LO (Head, Cybersecurity, MDEC) and Philip VICTOR (MD, Welchman Keen). They discussed their views and perspective that increased usage as well as new cloud adoption during the current crisis was a positive outcome of the lockdown.

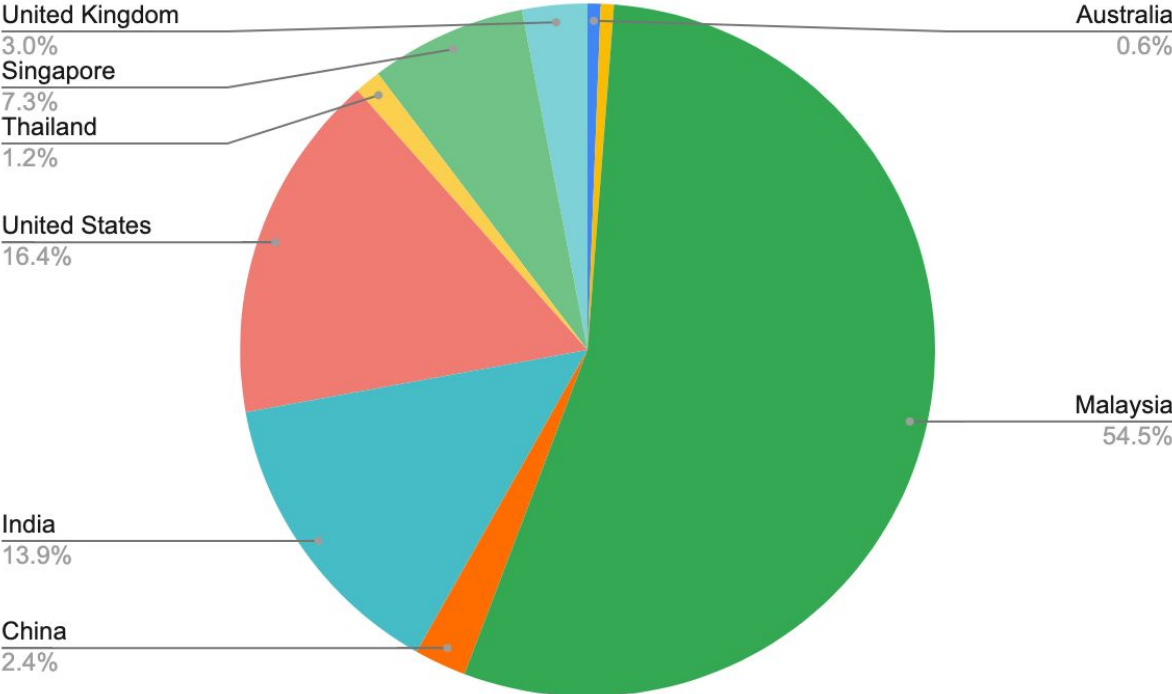

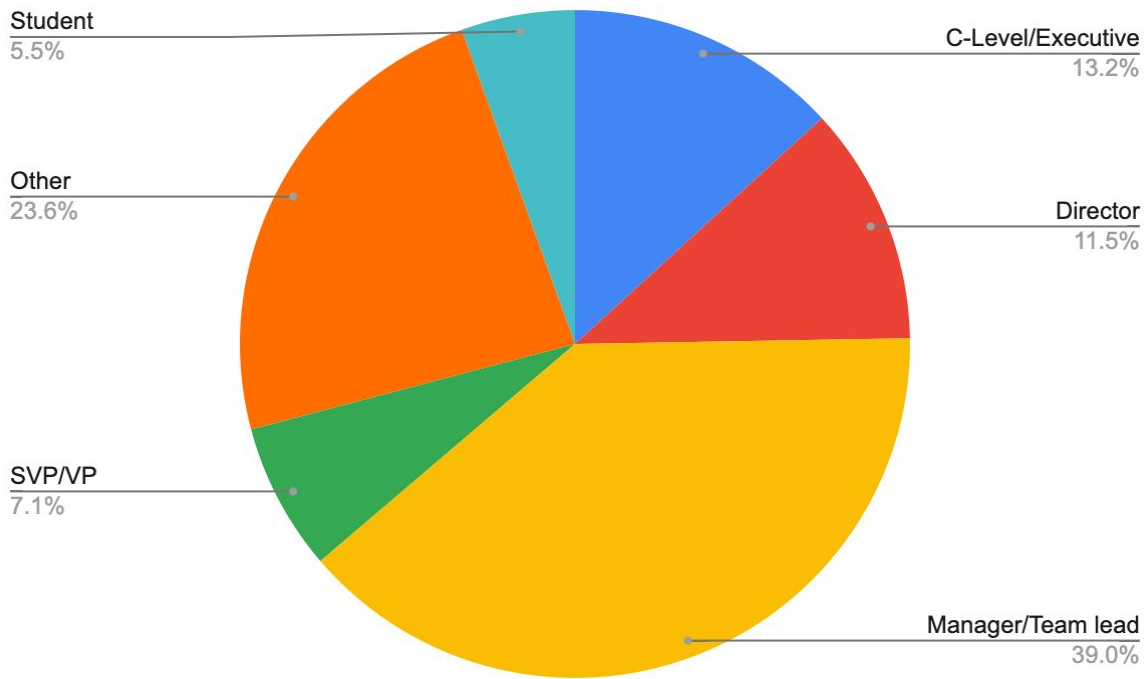

By Country

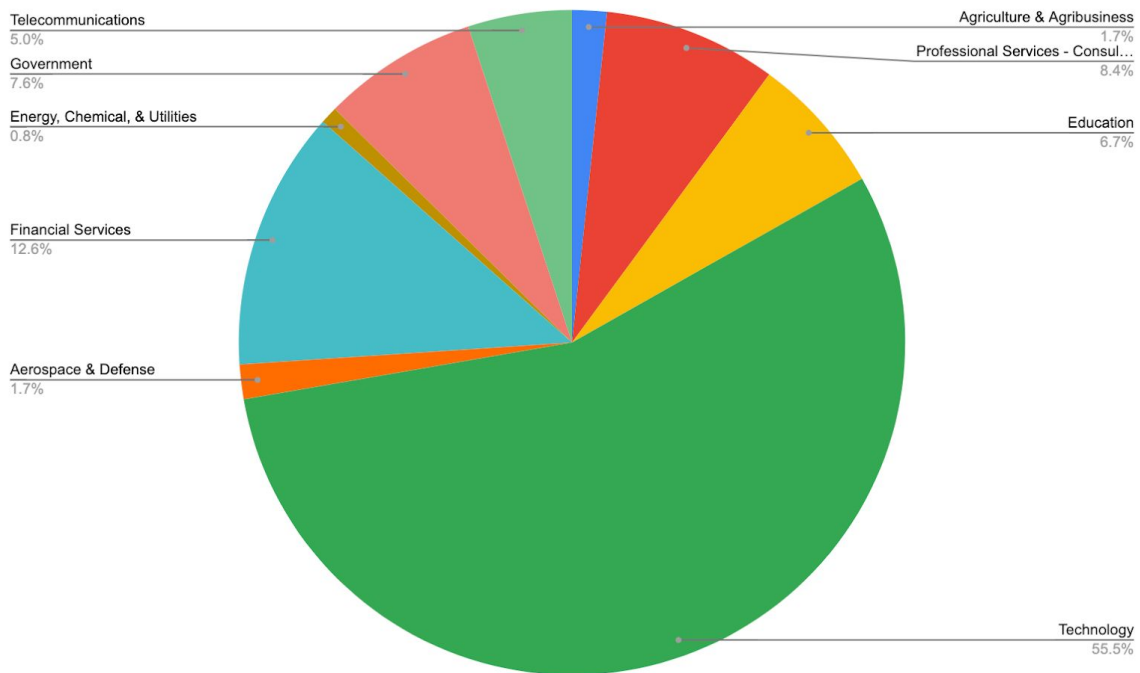


By Job Profile

The current COVID19 pandemic outbreak has arguably been a wakeup call for most organizations that faced increasing difficulties operating from the traditional on-premise model. Unknowingly, many organizations might not have been aware that they have been directly or indirectly accessing a wide variety of cloud computing services with services such as Microsoft 365, emerging technologies such as Internet of Things (IoT) and practices such as big data analytics. As another example, Malaysia's central bank releasing of its Risk Management in Technology (RMiT) guidelines last year has arguably spurred disruption that led to more rapid digital transformation which includes the movement to the cloud within the financial services industry. Based on the guideline's recommendation, financial institutions could adopt cloud services as long as they have performed comprehensive risk assessment prior to the adoption.

This presentation will deliver awareness of cloud security by covering some of the common cloud risks and potential challenges faced with cloud adoption. There will be sharing as well of appropriate security controls be it from management or assurance perspectives that organizations should consider when moving to the cloud.

Cloud-based infrastructure is very different from an on-premises data center and traditional security tools and strategies are not always able to secure it effectively.
