The Big Shift to the Cloud: Cloud Security in the Time of Covid -19

The onset of the pandemic has thrown normalcy out of gear. There is talk of a “new normal”, which continues to be defined and remains as broad as ever. The synapse between the COVID-19 pandemic and cloud security imperatives can be addressed with a call to action that the new cyber & cloud security strategy on the anvil can address. There must be sync with these modern realities and adaptation along with the willingness to innovate for future disruptions which will in turn reinvigorate our trust and boost our digital immunity.

Leading experts from the Philippines with domain proficiency and expertise discussed key issues and trends facing cloud security and cybersecurity today at this virtual Summit organized by CSA APAC and CSA Philippines Chapter on 11 November 2020.

PROGRAM

The CSA Philippines Virtual Summit commenced with an introduction from Ryan TY (Chairman, CSA Philippines Chapter) and welcome remarks from Dr. Hing-Yan LEE (EVP APAC, CSA).

The program saw a stellar line-up of two keynote addresses and two panel discussions key topics that included:

- “Navigating Troubled Waters”
- “Securing the Big Shift to the Cloud”

and two panel discussions on

- “Cloud Security Against the Top Threats in Cloud” and
- “Best Practices in Selecting Cloud Services”

Other industry thought leaders and eminent individuals in cloud computing and cloud security spoke on topics such as:

- In the opening keynote address by Timothy GRANCE (Senior Advisor for Emerging Technology, NIST) shared the changes in telework practices and NIST’s response to those changes. He also provided an update to NIST SP 800-46 and recommendations and resources for enterprise telework planning and implementation.
- Isa OJEDA (VP - Compliance Risk Management Officer, Multinational Bank) in the second keynote presentation shared the discussions around the cloud models, cloud security, and change management. Rethinking the Cloud Security strategy is now the main agenda of Philippine CISOs. The issues are: cloud threats are evolving fast and how the Philippines can secure the Big Shift to the Cloud.
- The first panel discussion on “Cloud Security Against the Top Threats in Cloud” was moderated by Ricson Singson QUE, (VP for Education, CSA Philippines Chapter) and panelists included Carlos TENGKIAT (CISO & Head of Information Security Governance Department, Rizal Commercial Banking Corporation), Paula Nones-RAMOS (Threat & Vulnerability Manager, Royal Caribbean) and Mark MISTAL (CIO/SVP, Inspiro). They discussed the business impact of the top threats on the cloud adoption and cloud-security-first mindset and how CSA can help the Philippines industries in their cloud security journey.
- The second panel discussion was based on “Best Practices in Selecting Cloud Services” where panelists such as Gonz GONZALES (Director, Information Technology Security, JG Summit Holdings, Inc), Reggie TAMAYO (Head for IT Management, Bureau of Treasury, Republic of the Philippines) and Johnny SY

(Information & Education Technology Consultant, Sterling Paper Group) discussed how the Cloud Control Matrix (CCM), CSA's Security, Trust & Assurance Registry Program (CSA STAR) are useful tools for selecting cloud services. The panel was moderated by Johanna MORTEL (Advisory Board Member, CSA Philippines Chapter)

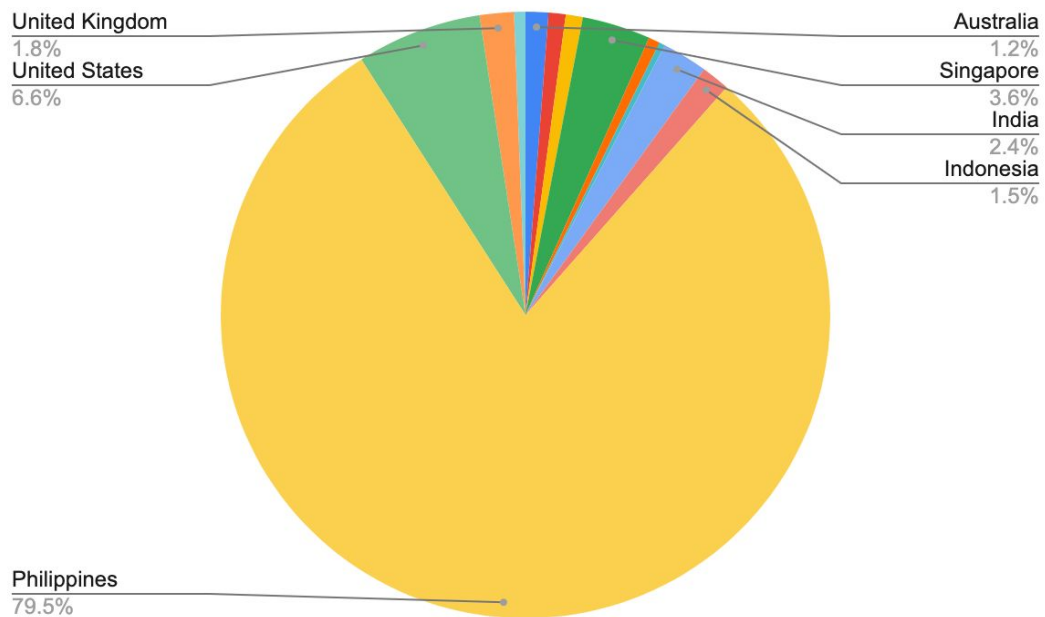




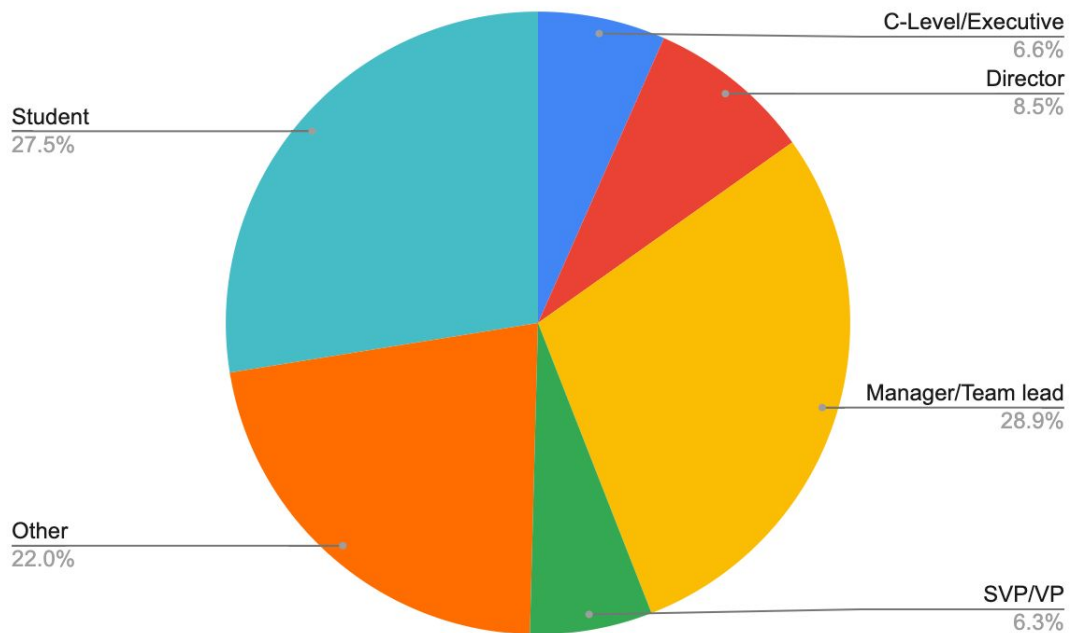
STATISTICS

By Country

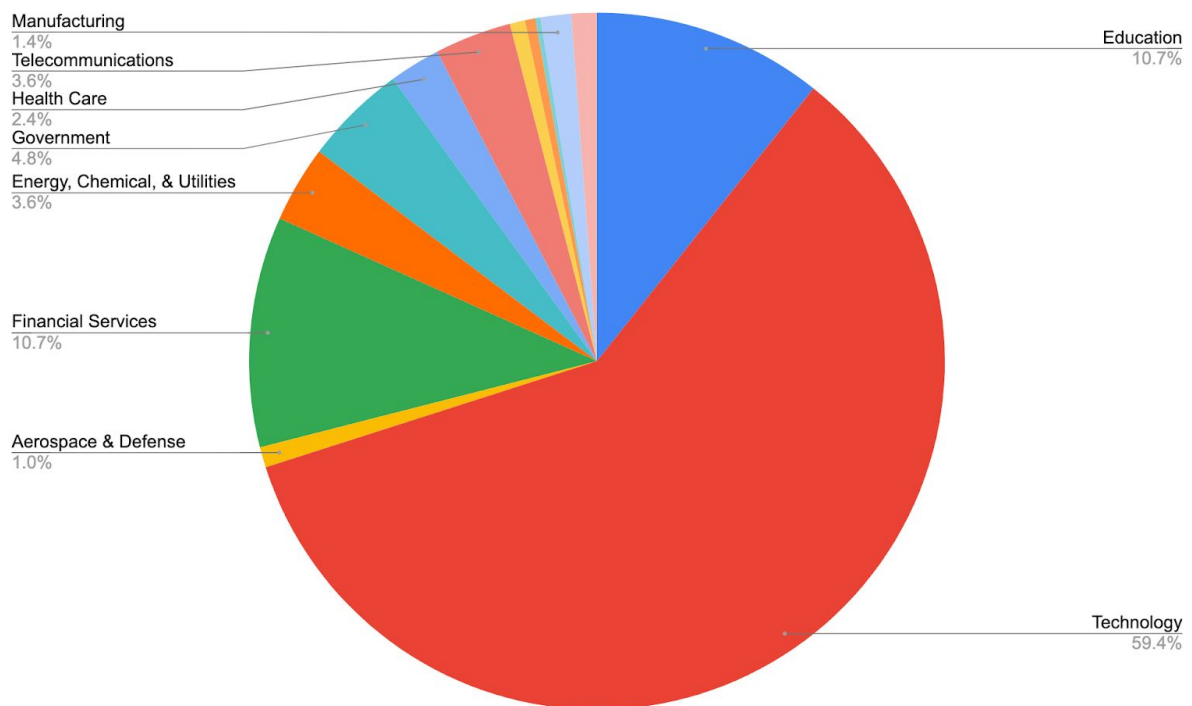


By Job Profile
